COVID Instant Order-104

Sub: HMFw-COVID-19- certain instructions regarding CC TV in the Notified Covid Hospitals in the State –Orders – reiterated.

Ref: Covid Instant order -77, Dated: 07.08.2020

In view of the Covid Pandemic in the State, orders were issued in the ref. cited, regarding installation of CC Cameras and CC TVs in the notified Covid hospitals in the State.

In view of the doubts and clarification requested from various authorities the orders issued earlier are herewith reiterated for strict compliance with immediate effect to strengthen the Covid Hospitals for effective utilization and to render proper treatment to the patients in the State.

CCTV Management:

CC Cameras shall be installed in every Covid Notified Hospital with beds allotted to the Covid patients are 20 and more.

The CC Cameras are to be placed in Covid wards at a place which covers all the beds.

All the wards are to be covered with CCTV system and feeds are given to the hospital control room, District control room and State control room.

CCTV feed shall be available at Notified Covid Hospitals District Collectorate CC TV cell and State headquarters CC TV internet connection at these places shall be arranged by Hospital Superintendent / Managers..

Hospital Nodal Officer shall physically be present at the location of the CCTV feed monitor and shall examine the following:

The Hospital Superintendent/Incharge shall monitor the movement of the doctors and nurses who are visiting the wards and taking care of patients.

The CC TVs show the sanitation condition of all the wards. This should be observed such that wards are clean and hygienic.

The footage should show whether the toilets are cleaned 4 times a day at 5 Am, 8AM, 11 Am & 4Pm every day.

The footage should show whether food is being supplied at the designated time and he/she shall also check the food for quality at all three times.

The District Quality team of NHM in each district shall coordinate the installation of the CC TVs in all the Covid Notified Hospital and shall be coordinated for any repairs of the CC Camera and CC TVs.

The District Quality team in each district shall coordinate installation of Inter Net necessary for each Notified Covid Hospital without any interruption with sufficient ILL capacity.

All the alerts which are raised from State/District monitoring cells should be redressed by the concerned Nodal Officer of the Notified Covid Hospital with in SLA of 30 minutes.

These orders are issued for strict compliance and any deviation will be viewed seriously.
