**Sub:** HMFW –COVID-19 –Committee constituted for allocation of drugs for management of Mucormycosis in Government and Private hospitals-Orders issued.

#### COVID INSTANT ORDER -123-A

The Government of Andhra Pradesh has communicated the management protocols for Mucormycosis vide COVID Instant Order 123, dated 18.05.2021. Many Government and Private hospitals designated as COVID hospitals are treating patients suffering with Mucormycosis.

Government hereby constitutes a committee with following members for allocation of Inj. Liposomal Amphotericin-B, Posaconazole oral suspension and Injection Posaconazole 300mg to the patients undergoing treatment in Government and private hospitals (COVID hospitals under Aarogyasri).

- 1. Superintendents of the Teaching Hospital
- 2. DM&HO
- 3. DCHS
- 4. Joint Collector (V&WS)
- 5. AD Drugs

Joint Collector Development & V&WS will receive the request for Inj. Liposomal Amphotericin-B, Posaconazole oral suspension and Injection Posaconazole 300mg from the Governmenthospitals for specific patients and place it immediately before the committee. The patient-wise request from hospitals should have a detailed recommendation of a team of three (3) specialist doctors from the hospital, which is indenting the drug, after assessment of the patient's condition.

The committee shall allocate therequired drug for management of Mucormycosis to the patients after satisfying the need.

#### **Procedure of allotment to Private Hospitals:**

1. Any designated private hospital which can source Inj. Liposomal Amphotericin-B, Posaconazole oral suspension and Injection Posaconazole 300mg on their

own are free to purchase through their own sources. Only the Covid designated private hospitals which are facing shortage of above drugs shall place the indents to the committee at least 2 days in advance in the prescribed application format.

- 2. Joint Collector Development & V&WS will receive the request for Inj. Liposomal Amphotericin-B, Posaconazole oral suspension and Injection Posaconazole 300mg from the private covid hospitals for specific patients and place it immediately before the committee. The patient-wise request from hospitals should have a detailed recommendation of a team of three (3) specialist doctors from the hospital, which is indenting the drug, after assessment of the patient's condition.
- 3. The committee shall allocate the required drug for management of Mucormycosis to the patients after satisfying the need.

The Managing Director, APMSIDC shall procure the required number of drugs and issue them to the central drug store from where there will be drawn and used with recommendation of the above committee.

District Collectors are requested to review the indents placed by the Covid Pvt hospitals and issues made by the Assistant Director, Drug Control Administration on daily basis and take necessary measures for proper usage to the needy patients as per guidelines.
